## STEP 2: DECLARATION OF FINANCIAL CAPACITY

### TRAVEL, TUITION & LIVING EXPENSES

As a student being assessed for a Simplified Student Visa Framework (SSVF) application, you must *declare* that you have enough money to pay for travel, tuition, living expenses, and health insurance for yourself, your partner (if applicable), and your dependent children (if applicable), for *the duration* of your stay in Australia. Together with this declaration, you must provide *evidence* of your financial capacity for the *first 12 months* of your stay in Australia. Finally, your agent must explain to you that the relevant funds must be in your bank account *at least 3 months prior* to the commencement of your studies.

As suggested by the Department of Immigration and Border Protection (DIBP), the table below outlines in Australia dollars (AUD) the minimum annual requirement you will need in order to be eligible to obtain a student visa. **NOTE: The below amounts do not necessarily represent the cost of living in Australia.**

## STEP 3: STATEMENT OF PURPOSE

### SoP

Please attach a Statement of Purpose outlining the reasons for undertaking your intended course/s at Qii. The Statement of Purpose must be the statement you use to lodge with your visa application with the Department of Immigration & Border Protection (DIBP).

The Statement of Purpose needs to be objective, yet it must cover the following points:

- your reasons for choosing to undertake the course of study specified in your application
- your reasons for choosing to study in Australia rather than in your home country
- your reasons for choosing to study in Australia rather than in another country
- your reasons for choosing Brisbane rather than another Australian city
- your reasons for choosing Qii rather than another provider
- the relevance of your intended course/s to your academic and/or employment background
- the relevance of the course/s to your future career
- talk about your ties back in your country (such as family, job, friends)
